2023/24-2029/30

OBJECTIVE OF THE ZESTP

The main objective of ZESTP is to fast track improvements in access, participation, quality and relevance of education and skills.

This will be achieved through improvements in:

- Teaching and learning environment;
- Curriculum development and delivery;
- Teachers workforce planning and management;
- Innovation and digital Learning;
- Financing and private sector engagement; and
- Education administration and governance including up to date policy, legal, and regulatory frameworks.

Plan Development Methodology/ Process

ZESTP development started with the undertaking of the Education Situation Analysis (2022) to provide for the main source of evidence.

Additionally, the Ministry of Education and Vocational Training (MoEVT) formulated a Task Force to propose transformational aspects for the sector which came up with key Ministerial recommendations on Zanzibar education transformation.

A team of consultants was engaged to facilitate the prioritization process for ZESTP as well as support discussions with key stakeholders and ultimately the drafting of the document.

ZESTP Reform Areas

The ZESTP 2023-30 focusses on the Reform Areas that were identified in the Ministerial Taskforce for Education Reform (MTER) report summarized as follows:

- RA 1.1: Teaching and Learning Environment;
- RA 1.2: Curriculum Development and Delivery;
- RA 1.3: Teachers Workforce Planning and Management;
- RA 1.4: Innovation and Digital Learning;
- RA 1.5: Sustainable and aligned financing; and
- RA 1.6: Educational Administration and Governance.

ZESTP Programmes

Identified interventions for each Reform Area have been shown per programme as follows:

- Pre-Primary and Primary Education (PPE & PE);
- Secondary Education (SE);
- Vocational Education and Training (VET); and Alternative Learning and Adult Education (ALAE);
- Technical and Higher Education (T&HE);
- Quality Assurance and Cross Cutting Issues (QA & CCIs);
- Management and Administration (Mgmt. & Admin).

This was considered essential in that the MoEVT uses programme-based budgeting in preparation of Medium Term Expenditure Framework (MTEF).
